



#### **Storage instructions:**

As the main component of the FiberWise<sup>™</sup> is natural fibres, there is a risk of moisture absorption from the air.

The atmosphere should be maintained to provide good ventilation and low humidity, below 50% RH.

\*Colours, weights and dimensions of the products may differ due to the nature of the material, moist variations, production variations, storage and transport conditions.

#### **Recyclability and disposal:**

**The FiberWise™ is recyclable in appropriate systems** The fibre part can be separated from the PE/EVOH/PE film and can be recovered where facilities exist for recycling (paper or cardboard) or alternatively incineration with energy recovery.

The fibre part is industrially biodegradeable and compostable within 90 days.

The PE/EVOH/PE film can be disposed as household waste for incineration with energy recovery.
